NATIVITY OF S. JOHN THE BAPTIST¹

INTEGRITY

'Thou shalt go before the face of the Lord to prepare His ways.' - S. Luke i.76

S. John the Baptist stands out pre-eminent for the complete integrity of his character. He was ready to decrease in order that Christ might increase, to sacrifice himself wholly for the cause. Many people are ready to fight for a good cause, provided they themselves are in the front rank, but when for the good of the cause it would be better for them to give place to another, they go out of the battle altogether. S. John was completely ready to take a lower place, and to see his own disciples leave him and follow Jesus. Again, he was ready to say the same thing in any company. He preached the same doctrine in the royal chapel as in the market-place, and, if he taught the publicans that they must give up their sins, he also denounced the crime of Herod, who was living with his brother's wife. He gave our Lord that purest devotion, that he was ready to leave Jesus for Jesus' sake, to go from the manifest presence in the house of Nazareth to labour in the wilderness for the coming of the kingdom.

It is part of the training of our character that we should recognize that there is much we cannot do; all we can do is to make ourselves instruments in God's hands, to use or lay aside. Our part may be to sow that others may reap, and we must be ready to stand aside for the good of the cause. We must try to get that integrity of character which will make us perfect servants in the cause of the kingdom. There is often a vocation to follow S. John the Baptist in leaving conditions where we have spiritual luxury, to labour in self-effacing ways that in some wilderness the Faith may be born.

The Rector's Ramblings

I'm writing this two weeks after the 2018 Diocesan Synod. This was probably the best one yet. It was held at The Waterfront Inn in The Villages, Florida. The attendance was around 40 people. The Synod was hosted by St. Albans Anglican Church in the nearby town of Lady Lake, Florida. The priest in charge is Fr. Gregory Koon. Some of you may have remembered him from the 2013 Synod held here at All Saints. Our people who attended, besides myself, were Deacon and Marcia Wilson, Jane and Fred Moeller, Carol O'Sullivan, and Samuel Talabi.

The Synod began each day with Morning Prayer followed by Mass. I had the privilege of celebrating Mass on the Thursday of the Synod. At the end of each day we had Evening Prayer. The Synod banquet was held on Thursday evening. And the Synod Mass was held on Friday morning. There are pictures of both events in this issue.

One of the most important parts of a Synod is the meeting of the Standing Committee. All Saints has three members on the six member Committee: myself, Carol O'Sullivan and Marcia Wilson. The Committee's main function is to interview men for Holy Orders. The Committee, along with the Board of Examining Chaplains, interviewed six men for Holy Orders and two priests who have an interest in serving in our Diocese. Deacon Shannon Clark from Holy Comforter in Montevallo, Alabama was approved as a postulant for the Priesthood. Paul Drayton was granted another year to complete his studies for the diaconate. Samuel Talabi was admitted as a postulate for the diaconate. Three other men were also approved as postulants for the diaconate. Please keep Paul and Samuel in your prayers as they prepare for their service to God and All Saints.

Christian Proficiency

In my last article, I told you what a Rule of Life is. A Rule of Life is “a single, systematic pattern of prayer and worship.”¹ A Rule of Life needs to be based upon the three-fold Rule of the Church which is Mass, Daily Office, and private prayer. Now, in this case Rule doesn’t mean the same as following a list of ‘rules.’ A Rule is a means to an end and never an end in itself. In other words, it is not a check list. “I went to Church on Sunday.” Check. “I said the Daily Office today.” Check. “I prayed not once, but two times today.” Double check. So before we get down to the matter of constructing and using a Rule, let’s clear up some common misconceptions about the Rule.

First, a “Rule is ‘embraced’ not ‘promised.’ It would be Pharisaical, legalistic and quite unchristian solemnly to promise to ‘keep’ a Rule; and it would involve the sin of pride and the heresy of Pelagianism² at least. [A Christian Proficient] is one who chooses to undertake his common obligations and duties, and to develop his personal spirituality, by acknowledging, accepting or ‘embracing’ some total scheme, system, pattern of ‘Rule’ of prayer.” A Proficient “is one who intends, and attempts, to order his life of prayer in a particular way, according to some clear-cut model. He may do it well or badly, he may fail seldom or often . . . but he can only ‘break’ his Rule . . . by giving up the whole principle of the thing.”

Second, a “Rule is wholly opposed to legalism.” Here’s an example: say you Fast from (give up) chocolate for Lent. Your motive, “the end for which Rule is the means, is to deepen [your] spiritual life, to grow somewhat in the Love of God, decrease [your] sins, make a definite renunciation of the pleasure of [chocolate] and to offer it to God, and give its value to a [worthy charity.]” Now say on Ash Wednesday, you ate a chocolate bar. Have you broken the rule? A Pharisee would say yes. And that having ‘failed’ the person might as well give up the whole thing. But “by the principle of the Rule . . . this [person] has made a minor ‘fault’. He would simple carry on with his Rule; it would be . . . wrong to speak of his ‘starting again’ for that would imply that something had been irrevocably ‘lost.’” So, again you ‘break’ the Rule only by giving up.

Third, a “Rule is neither artificial nor a burden, but the principle of civilized life.” Perhaps the best way to explain this is to say that we order our ‘regular’ life with simple, practical rules. So, there are good reasons to order our spiritual life also. I get up at 6:20 am, I brush my teeth after breakfast, I leave the house by 7:45 to be able to get to work by 8:30. I go to Communion on Sunday. I say Morning Prayer at 10:00 am during my morning break. I say Evening Prayer at 10:00 pm before going to bed.

Fourth, “Breach of Rule is not sin. . . . A breach of Rule . . . is strictly amoral; thus the *cause* of a fault might be sinful, negative, or virtuous.” If you miss Church because you are lazy, you have sinned and committed a ‘fault’, but the sin is sloth, not the missing of Church. If you miss Church because you have a flat tire, you have committed a ‘fault,’ but there is no sin. If you miss Church because you stopped to help someone who was in a traffic accident, you have committed a ‘fault,’ but you have gained the “virtue . . . of a positive act of charity.”

Fifth, “Rule is, and must always remain, variable.” Some people have the idea that once a Rule has been embraced, “you must ‘stick it out’ at all costs for ever!” This is not true, a Rule maybe ‘relaxed’ or ‘modified.’ An example, might be when you are sick, or on vacation, or engage in charitable duties that temporarily overwhelm you. Another example is this, say you abstain from meat on Fridays, you are invited to dinner on Friday night. Your

host serves a beef roast. You could make a big deal of not eating meat on Fridays, thereby embarrassing your host. Or, you could simply eat what you have been served. You have committed a 'fault,' but you have gained the virtue of being a good guest. Finally the Rule is . . . variable . . . according to our progress through life, and will probably need revision every two or three years, as we advance or as our circumstances change. . . . We must never lose sight of the absolute dogma that Rule is a utilitarian device."

In my next article, I'll discuss the principles that go into constructing a good personal Rule.




